### Description:

Ranking and authorize staff to negotiate an agreement for RFP 23-403 CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Street.

### Recommended Action:

Approve the ranking and authorize staff to negotiate an agreement for RFP 23-403 CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Street:

1. AE Engineering, Inc.
2. Causseaux, Hewett, & Walpole, Inc. d/b/a CHW
3. Kisinger Campo & Associates

Authorize staff to negotiate agreement with top ranked firm, AE Engineering, Inc., and with the second ranked vendor Causseaux, Hewett, & Walpole, Inc. d/b/a CHW and the third ranked vendor Kisinger Campo & Associates, Corp (KCA), if negotiations with the top ranked vendor fail.

### Prior Board Motions:

February 23, 2016, Board of County Commission (Board) submitted safety grant application for SW 170th Street

September 12, 2017, Board approves Local Agency Program (LAP) agreement with Florida Department of Transportation (FDOT) for design of the roadway resurfacing and widening and authorizes Public Works Director to execute any additional agreements related to this project. Grant funding for construction is to be made available in subsequent years.

January 24, 2023, Board approves all projects previously on the Capital Improvement Program (CIP), including SW 170th Street, and additional local funding to supplement FDOT grant funds. Item 23-0357

**Fiscal Note:**

There is sufficient funds in both sections of this project for this contract. There is the County portion which is funding in account 341.79.7910.541.63.99 and there is the FDOT grant portion in account 329.79.7910.541.63.99. Project# 9177912.

**Strategic Guide:**

**Background:**

The SW 170th Street project was programmed to reduce the potential of sideswipe crashes and lane departure crashes. FDOT requires the County to deliver the project via LAP.

In April 2020, the Public Works Director executed a LAP agreement with FDOT for the funding of construction and CEI services for the widening and resurfacing of SW 170th Street from the Levy County line to south of the City of Archer, as authorized by previous Board action (see above). Construction is to be completed in Fiscal Year 2023 (FY 23).

RFP 23-403 CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Street was released on January 18, 2023. The deadline for receipt for RFP 23-403 CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Street was March 1, 2023, five (5) vendors responded.
