First Amendment to Agreement 13479 with BI Incorporated "BI", for Offender Monitoring Solutions, for Court Services.

Description:

First Amendment to Agreement 13479 with BI Incorporated, for Offender Monitoring Solutions, in the amount not to exceed "NTE" \$390,000.00 annually, for Court Services. This amendment increases the NTE amount from \$266,000.00 to \$390,000.00 and extends the term through September 30, 2025. The Addendum Agreement is based on the Omnia Partners, City of Mesa, Arizona Solicitation 2022118. Also, Fiscal Services is requesting approval of Budget Amendment 24-00002338 to move funds.

Recommended Action:

Approve and authorize the Chair to execute First Amendment to Agreement 13479 with BI Incorporated, for Offender Monitoring Solutions, in the amount not to exceed "NTE" \$390,000.00 annually. Also, Fiscal Services is requesting approval of Budget Amendment 24-00002338.

Prior Board Motions:

January 25, 2022, the Board approved the Single Source and Agreement 13314 with BI Incorporated. Item 22-0056.

September 27, 2022, the Board approved Addendum Agreement 13479 with BI Incorporated. Item 22-0824.

Fiscal Note:

001.36.3620.523.34.00 (\$31,000) and 001.36.3680.623.34.00 (\$93,000) for a total increase of \$124,000. Amendment will change the Not to Exceed amount to \$390,000.

Background:

Court Services provides Electronic Monitoring and Transdermal Alcohol monitoring at the discretion of the Courts. The Judiciaries have increased the usage of these devices for Probationers and Pretrial

defendants. There has also been an increase in the average daily population in the jail, therefore more defendants awaiting trial, sentencing and/or release. Due to these increases, Court Services is asking for an additional \$124,000 to the existing budget, bringing the not to exceed amount in the agreement to \$390,000.

Since its inception in FY02, defendants in a pretrial status or sentenced misdemeanor offenders have been supervised by the Department of Court Services' Pretrial Services and Probation programs by utilizing Electronic Monitoring (EM), Global Positioning Satellite (GPS) and Transdermal Alcohol Detector (TAD) as a special condition. These defendants are closely supervised and monitored in the community utilizing evidence-based technology, thereby reducing the need to remain in custody.

BI means Behavioral Intervention.

This purchase is exempt from the County's competitive bidding requirements pursuant to Section 22.3-302 (13) of the Alachua County Procurement Code, Procurement of Supplies or Services under Contract with cooperatives, including cooperatives that the County participates in accordance with Article 10, Section 22.10-201 (Cooperative Purchasing Authorized), providing the vendor extends the same terms and conditions of the Contract to the County; however, since the dollar amount of the purchase exceeds the purchasing authority of the Procurement Manager, this is being submitted for Board consideration and approval.
