**Commissioner Cornell moved** to direct staff to create a policy for non-profit and other entities that receive County funding be required to display that funding source publicly in a form that is at staff's discretion. The motion carried 5-0.

#### I. Action Items

 World Masters Update from the Local Organizing Committee and West End License Agreement - 24-00537

Local Organizing Committee Member Steve Rodriquez presented the above item.

Chair Alford, Commissioner Cornell, Commissioner Prizzia, County Manager Lieberman, Assistant County Attorney Diane Johnson, Commissioner Wheeler, and Commissioner Cornell presented comments.

**Commissioner Cornell moved** the following:

- 1. Hear update about the 2025 World Masters Indoor Athletics Championship event.
- 2. Authorize the County Manager to execute a license agreement for the property known as West End with the Alachua County Local Organizing Committee, Inc and to execute any amendments consistent with the use of the property for the stated use, at no cost and contingent on the purchase of West End, and with only authorized improvements permitted by licensee and all improvements left on property following the end of the license term.
- 3. Set aside (not to exceed) \$645,000 from Tourist Development Tax reserves for necessary expenditures related to the property known as West End, as authorized by Florida law, and not covered by the State appropriation for the World Masters event. Any use of these Tourist Development Tax funds would require Board approval.
- 4. Approve the corresponding budget amendment moving Tourist Development Tax funds from reserves to the appropriate accounts.
- 5. That staff agenda and return to the Board in August or September as soon as possible but not later than September with another update and a detail plan of what improvements will be made and continue to work with the Friends of West End in conjunction with the Community Engagement Plan.

Commissioner Prizzia, County Manager Lieberman, Assistant County Manager Peebles, and Commissioner Cornell presented comments.

By consensus, the Board agree to allow the divestiture to occur by the end of the calendar year to allow the investment firm to time the sale of investments to not realize loses.

Mr. Hutchinson informed that Board that staff is targeting the July 9, 2024, meeting for the Public Hearing.

County Attorney Torres presented the rules and procedures for the hearing.

Deputy Clerk Donahey called on each Commissioner to disclose any exparte communications and issued the Oath to all those who wished to participate.

No ex-parte communications were disclosed.

Agent for the Applicant Clay Sweger, County Arborist Jessica Hahn, Commissioner Cornell, Growth Management Director Jeff Hays, Chair Alford, Commissioner Wheeler, Applicant Engineer Sergio Reyes, County Attorney Torres, and Commissioner Prizzia presented comments. Chair Alford requested staff schedule a meeting with Clay Sweger to discuss the County Stormwater Policy and some of the conflicts it creates with competing interests such as the preservation of trees.

Commissioner Prizzia moved to approve the proposed Preliminary Development Plan and Resolution DR24-23 based on a finding of consistency with the Alachua County Comprehensive Plan, and the Alachua County Unified Land Development Code. Direct staff to work with the applicant to identify ways the County could have protected more trees and provide input and feedback to the Board with regard to ways the Board could change code to increase tree protections within the urban services boundary. The motion carried 5-0.

# 3. Florence Landfill Settlement Agreement

Assistant County Attorney Corbin Hanson presented the above item.

Mr. Hanson stated that the County was not a party to this action. The participants have signed the agreement. In the agreement Florence agrees to the following conditions:

- To close the facility in eight and half years or when landfill reaches a height of 190 feet.
- Paving part of the entrance road and water systems to reduce dust issues.
- Water filters for some residents and others being connected to GRU water service.
- Continued monitoring
- Assurances that drywall will be shipped to a different facility.
- Testing of Boulware Springs

This agreement resolves the challenges from these participants to the DEP Permit. The Special Use Permit of the County is currently under administrative extension. They have not withdrawn their application at this time. There is ambiguity in the State Law so there is not a definitive answer as to when the extension will expire.

Commissioner Cornell, Commissioner Prizzia, and Chair Alford presented comments.

Just to be admitted was \$4,000. She would like to receive some billing information form Shands regarding the fee structure for the eastside clinic as well as an update on the construction and the expected opening date.

County Manager Lieberman sated that a volunteer coordinator has been hired and is working on creating a sight for volunteers and provide recognition. She stated that at the discussion in July would be the perfect time to have the discussion with the Board. As for the UF Health Facility she will request the information and she believes August is the target for it to open.
