### Background

**Location:** Alachua County is located in North Central Florida. The County government seat is situated in Gainesville. Gainesville is located 70 miles southwest of Jacksonville, 129 miles southeast of Tallahassee, 140 miles northeast of Tampa - St. Petersburg and 109 miles northwest of Orlando. Alachua County has a population of over 250,000 and a regional airport. The County itself consists of a total area of 969 square miles.

**Form of Government:** Alachua County is governed by a Board of five (5) elected County Commissioners and operates under the established County Manager Charter form of government. In addition to the five County Commissioners, there are five elected Constitutional Officers: Supervisor of Elections, Sheriff, Clerk of the Court, Tax Collector, and the Property Appraiser. The Alachua County Attorney also reports to the Board.

Our food service directly benefits the target population by immediately reducing the symptoms of poverty and providing services directly to participants. Of total utility costs, 60% are allocated to providing shelter residents running water for drinking, bathing and toilets; sewage fees; electricity for HVAC; personal refrigerator storage; lights; and computer lab access including printers (electricity only for the purpose of this question). This service directly benefits the target population by immediately reducing the symptoms of poverty and provides services directly to participants. Further, of all waste disposal costs, 90% of all costs are allocated to food services for shelter residents and community meals. The remaining cost is split evenly between administrative staff and shelter residents. This service directly benefits the target population and provides services directly to participants.
