## FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND INDIGITAL, INC. NO. 13219

THIS First AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and INdigital, Inc, a Foreign for Profit Corporation with a principle business located at 1616 Directors Row, Fort Wayne, IN 46808 hereinafter referred to as "Professional." Collectively hereinafter County and Professional referred to as "Parties."

## WITNESSETH:

WHEREAS the Parties previously entered into a Professional Services Agreement dated 18 March 2022 for Next Generation Cores Services (NGCS) and Emergency Services Internet Protocol Network identified by No. 13219 (the "Agreement"); and

**WHEREAS**, the Parties desire to amend the Agreement to allow the Professional to provide increased network bandwidth; and

**NOW, THEREFORE**, the County and Contractor agree to amend the Agreement as follows:

A. <u>Amendment.</u> Section 5 of the Agreement, Method of Payment, sub-section 5.1, is amended in its entirety to read as follows:

5.1 The Professional shall be paid for those services required by this Agreement not to exceed the sum of \$ 1,422,004.34, this amount includes previously invoiced and paid amounts, including the down payment amount of \$1,00,000.00, identified in Exhibit 6 Payment Schedule. allocated in the following manner:

5.1.1 Reference section 5.1 above, one-time non-recurring charges of \$31,526.24 are included within the amount of \$1,422,004.34.

5.1.2 After the down payment by the County of \$1,000,000.00, the amount due the Professional on an annual basis for the period beginning 1 October 2024 and concluding on 30 May 2027 is \$84,747.12. Prior to 1 October 2024 and beginning on the go-live date of 21 March 2024, which is the first day of invoicing, the annual amount invoiced to the County was \$81,883.21.

5.1.3 The annual payment from the County in the amount of \$84,747.12 is for database, routing, and in-bound text.

5.1.4 The year one (1) network bandwidth capacity is increased to 100MB with a monthly increase of \$238.66 effective 1 October 2024.

Amendment. Exhibit 7, of the Agreement titled "Network Diagram" is deleted and Β. A. replaced with a new network diagram depicting the 100MB AT&T and GRUCom network attached to this Amendment.

C. Effective Date. This Amendment shall be effective upon and after full execution of this Amendment by the Parties.

Original Agreement. Unless expressly amended herein, all other terms and provisions of D. the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
