Explain what equipment is needed, its cost, how it will be utilized, and economic return to your operations.

If you have taken the Extension Office's Agricultural Entrepreneurial Series, please attach your Farm Plan. (5 bonus points) I am 62-year-old women of color that runs a small farm. I have 11 beehives and approx. 100 chickens/Turkeys. I also have a vegetable and herb garden that I would like to start selling produce from. This grant would allow me to improve productivity by reducing the time spent with the current practice of manual transportation of equipment and supplies. Currently, I transport heavy equipment and supplies with utility hand trucks. This mode of transport limits the amount of work that can be completed on a daily basis. Which in turn, restricts the growth of my current business and inhibits further expansion such as adding additional hives and livestock, and by adding the sales of produce from my garden.

The purchase of a Utility Task Vehicle (UTV) will enable me to move our beehives and heavy equipment/supplies around the property. With the use of the UTV, it would allow me to place my chickens in mobile chicken coops/chicken tractors and use the UTV to pull the coops/tractors around the property. We lose approx. 25% of our chicken livestock annually to predators as we allow our chickens to free range. Placing our chickens in moveable chicken coops gives them the opportunity to safely free range. With the ability to safeguard and maintain my current livestock, I would be able to increase the number by 25% or more.

The cost of a UTV is \$5000-\$6000 depending on the make and model. (See attached sheet for description and cost of the BDX Crossfire UTV.

The UTV would reduce costs, increase efficiency, and increase productivity on my farm in the following ways:

- Utilize UTV for transport of mobile chicken coops/tractors to protect and add to my chicken livestock, thus increasing our egg production by 25% or more. This would Increase revenue by \$5,000-\$8,000 annually and lower costs from losses by \$1500 annually.
- 2. Enable us to add to our chicken livestock to raise meat birds in the mobile coops. This would increase revenue by \$15,000 annually from meat sales.
- An increase in efficiency and productivity would give me the additional time needed to maintain additional hives. Adding 10 more hives would increase honey yields by 250-300 lbs and increase revenue by \$3000-\$6000 annually.
- 4. Allow time for planting, harvesting and sales of produce Increasing revenue by \$10,000 annually.

	In conclusion, the purchase of the UTV would increase my annual income by \$40,000.
