All work, labor, material, and equipment required to mill and resurface SW 143rd Street from SW 170th Street to State Road 45. The scope of work includes milling the existing asphalt 1" and replace with 1.5" of asphalt.

Increase the Contract Amount \$80,039.90 by budget amendment to fund the work. Quantities and cost are to be tracked separately from the rest of the project. Funds from the FDOT grant are not to be used for this scope of work. The City of Archer, upon City Council Approval, will apply for an Infrastructure SurTax matching grant to mill and repave SW 143rd Ave, which is a City maintained street, from SW 170th Street to State Road 45. Alachua County Public Works (ACPW) will invoice the City for the construction costs.
