Description:

First Amendment to Agreements with Jones Edmunds and Associates, Inc. (13519) and Cornerstone Environmental Group LLC (13520) for 23-140 Annual Landfill Compliance Monitoring and Solid Waste and Resource Recovery Consulting Services, for Solid Waste and Resource Recovery (SWRR). This amendment extends the term through September 30, 2026, with one (1) additional two (2) year term.

Recommended Action:

Approve and authorize the Chair to execute the First Amendment to Agreements with Jones Edmunds and Associates, Inc. (13519) and Cornerstone Environmental Group LLC (13520), not to exceed \$300,000.00 annually.

Prior Board Motions:

November 8, 2022, the Board approved the Ranking and Award of contracts for RFP 23-140 Annual Landfill Compliance Monitoring and Solid Waste and Resource Recovery Consulting Services, with the top ranked firm, Jones Edmunds & Associates, Inc., and with the second ranked firm, Cornerstone Environmental Group, LLC a Tetra Tech, Inc., in the amount Not to Exceed (NTE) \$300,000.00, for Solid Waste and Resource Recovery. Amounts for these contracts are tentatively budgeted in the FY25 SWRR budgeted in accounts: 400.76.7630.534.31.08=\$85,000 and 406.76.7650.534.31.08=\$140,000 (Professional Services Engineering).

First Amendments to Agreements for 23-140 Annual Landfill Compliance Monitoring and Solid Waste and Resource Recovery Consulting Services with Jones Edmunds and Associates, Inc. (13519) and Cornerstone Environmental Group LLC (13520), NTE \$300,000.00 for Solid Waste and Resource

Recovery. These Amendments extend the terms of the two Agreements through September 30, 2026, with one (1) additional two (2) year term. These Amendments also modify the payment schedule attached as an exhibit to the Agreements.

RFP 23-140 Annual Landfill Compliance Monitoring and Solid Waste and Recovery Consulting Services was advertised on May 18, 2022. The deadline for receipt of RFP 23-140 Annual Landfill Compliance Monitoring and Solid Waste and Recovery Consulting Services was June 29, 2022, two (2) vendors responded.
