#### THIRD AMENDMENT TO AGREEMENT FOR ANNUAL UNINTERRUPTED POWER SUPPLY (UPS) MAINTENANCE NO. #11782

THIS THIRD AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Eola Power, LLC, a Florida Limited Liability Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

#### WITNESSETH:

**WHEREAS**, the County and Contractor previously entered into a(n) Contractual Services Agreement dated 09/28/2020 for Preventative Maintenance of Uninterrupted Power Supply (UPS) for Alachua County, identified by No. 11782 (the "Agreement"); and

**WHEREAS**, the County has elected its second and final option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County.

**NOW, THEREFORE**, the County and Contractor agree to amend the Agreement as follows:

- 1. <u>Amendment</u>. Sub-Section #1.1, of the Agreement titled "Term" is amended to read as follows:
  - 1.1. The County has elected to exercise its second and final option to renew the Term of the Agreement. Accordingly, the Term of the Agreement is renewed through September 30, 2025 (the "Second and Final Renewal Option Term"), unless earlier terminated as provided herein.
- 2. <u>Amendment</u>. The County name and address listed in sub-paragraph 4.2 of the Agreement titled "Method of Payment" is amended from Alachua County Public Works Department Director to Alachua County Facilities Management Director as provided below. All other portions of paragraph 4.2 remain unchanged by this Amendment:
