

**#13921 FIRST AMENDMENT TO AGREEMENT FOR ANNUAL LAWN MAINTENANCE
NW/SW LANDFILLS AND RCC NO. 13921**

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Boone Improvements Inc, a Florida for Profit Corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement for Annual Lawn Maintenance at Northwest and Southwest Landfills and Rural Collection Centers dated September 28, 2023, identified by No. 13921 (the “Agreement”); and

WHEREAS, the Parties desire to amend the Agreement to update and correct the Rate Schedule contained in Exhibit 2 of the Agreement.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. Exhibit #2, of the Agreement titled “Rate Schedule” is amended in its entirety and replace with the updated Exhibit 2 attached to this Amendment.
- B. Effective Date. This Amendment shall be effective upon execution by both Parties.
- C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.




