SECOND AMENDMENT TO AGREEMENT FOR ANNUAL MOSQUITO MITIGATION SERVICES NO. (#)11970

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Clarke Environmental Mosquito Management, Inc., a foreign corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the County and Contractor previously entered into a(n) Contractual Services Agreement dated 05/25/2021 for surveillance, monitoring and eradication of disease-bearing mosquitoes in unincorporated areas of Alachua County, identified by No. 11970 (the "Agreement"), and renewed the term of the Agreement with a First Amendment, dated June 29, 2022; and

WHEREAS, the County has elected its option to again renew the term of the original Agreement to allow the Contractor to continue to furnish the goods or services to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #1.1, of the Agreement titled "Term" is amended to read as follows:
 - 1.1 This Agreement is effective upon execution by both Parties, and continues through September 30, 2026, unless earlier terminated as provided herein.
- B. <u>Effective Date</u>. Upon and after full execution of this Amendment by the Parties, this Second Amendment shall be effective on October 1, 2024.
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Second Amendment shall prevail.
