

**THIRD AMENDMENT TO CONTRACTUAL SERVICES AGREEMENT BETWEEN
ALACHUA COUNTY AND PUBLIC CONSULTING GROUP LLC FOR FLORIDA
PEMT PROGRAM REQUIREMENT COMPLIANCE NO. 12024**

THIS THIRD AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Public Consulting Group LLC, a Foreign Limited Liability Company, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WHEREAS, the Parties previously entered into Contractual Services Agreement for Florida PEMT Program Requirement Compliance dated June 22, 2021, identified by No. 12024 (the Agreement") based on a Palm Beach County Request for Proposal #19-020/SS; and

WHEREAS, the Agreement was amended and renewed (the "First Amendment") by the Parties on September 14, 2022, to extend the term of the contract through August 19, 2024; and

WHEREAS, the Agreement was amended by the Parties on March 14, 2023, include the Contractor's Premium Professional Services on the Medicare Ground Ambulance Data Collection (MGADC) system (the "Second Amendment"); and

WHEREAS, the Palm Beach County has extended the services with the Contractor to August 19, 2029, through the execution of Contract SS750876/MB; and

WHEREAS, the Parties desire to amend the Agreement to extend the term of the Agreement to coincide with the Palm Beach County Contract.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- A. Amendment Section 1 of the Agreement, Term, sub-section 1.1 is amended to read as follows:
 - 1.1. This Agreement is effective upon execution by both Parties continuing through August 19, 2029 unless earlier terminated as provided herein.
- B. Effective Date. This Third Amendment is effective upon and after full execution by the Parties.
- C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect.
