

**THIRD AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY
AND CITY OF GAINESVILLE FOR AGE BASED FARE FREE TRANSIT PILOT**

THIS THIRD AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and City of Gainesville, Florida, a municipal corporation of the State of Florida ("City"), who are collectively referred to as the "Parties."

WITNESSETH:

WHEREAS, the County and the City previously entered into Agreement between Alachua County and City of Gainesville for Age Based Fare Free Transit Pilot dated September 28, 2021, First Amendment dated February 10, 2023, and Second Amendment dated March 8, 2024, (the “Agreement”); and

WHEREAS, the Parties have agreed to extend the term of the Agreement to allow the City to continue providing service to Alachua County; and

WHEREAS, the Parties desire to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the Parties agree as follows:

- A. Amendment. Article IV of the Agreement titled "Term of Agreement" is amended to read as follows:

The Agreement is amended to extend the term through September 30, 2025.

- B. Effective Date. This Amendment shall become effective on October 1, 2024.

- C. Fixed Fee. The County shall pay to the City up to \$115,000.00 during the period of October 1, 2024 through September 30, 2025 (FY25) for the age based fare free transit pilot program regardless of the number of individual trips documented by the Regional Transit System. Payments by the County to the City shall be made in equal quarterly amounts up to \$28,750.00 for the period beginning October 1, 2024 through September 30, 2025 (FY25). In the event that the State of Florida provides funding for trips that are the subject of this Agreement, the payment amount will be reduced by a corresponding amount.

- D. Service. The City agrees to provide bus service in accordance with the specifications of the age based fare free transit pilot program outlined in the Agreement for the period of time commencing October 1, 2024 through September 30, 2025 (FY25), regardless of the number of individual trips documented by the Regional Transit

System.

E. Original Agreement. Unless expressly amended herein, all other terms and provisions of the Agreement between the Parties shall be and remain in full force and effect.
