It doesn't make sense. If these items were able to be bid on per 1000 square feet of the area being treated plus a minimum mobilization cost to compensate for any treatment under 1000 square feet, It would make it much easier for us contractors to put together quotes for these services. If you were to give an acre to walk through but only treat 15 trees, it wouldn't be worth the time of the contractor. On the other side if you give an area completely infested the contactor could exhaust the funds for the project rather quickly. 2. If the contractor applies a basal bark application in a thicket is the contractor going to have to spend time counting each individual stem treated? 3. What qualifies as a tree? 10 feet tall? Would that indicate that we can't charge for a tree treated at 5 feet? 3 feet?

Answered by Neil Greishaw: 1. The miscellaneous services is not a one size fits all. The real world application of this will be individual requests for proposals that must match invoice amounts for billing. The awarded contractor will be compensated for their services and any requested proposals need to have some frame of reference, reflected in the pricing table. That being said, if a minimum mobilization cost for a treatment area of less than 1000 ft. sq. is a reasonable threshold for bidding purposes, we will edit the pricing table to reflect this. It is realistic we would request stump treatment of a line of freshly cut Chinaberry trees greater with greater than 20" diameter cut stumps. These will typically be in the Right of Way adjacent to County maintained roadways with easy access. 2. Not necessarily. Pricing table will be edited to reflect measurements mentioned in response to question #1 above. 3. A tree will defined be as a woody single trunked perennial species that exceeds 10' in height and a two inch diameter stem/trunk. Less than this size, herbaceous, or with multiple trunks will be considered a shrub. All accepted and completed work will be receive compensation.
