Authorize staff to negotiate an agreement with the top ranked firm. Should the staff be unable to negotiate a satisfactory agreement with the top-ranked firm, negotiations with the unsuccessful firm will be terminated. Negotiations with the second-ranked firm may be undertaken in the same manner in order of ranking until an agreement is reached, and so forth.

#### **Prior Board Motions:**

At the Board's November 14, 2023, meeting Commissioner Prizzia moved the following: 1. Approve the work scope and authorize staff to advertise the RFP after reviewing the performance indicators and requirements and consider reducing the number of requirements with regards to deliverables and bring recommendations back to the Board for approval. 2. Continue food system solutions engagement and report back to the Board in March 2024 with findings of the food system solutions. 2nd Commissioner Cornell Chair. The motion carried 5-0.

At the Board's December 6, 2022, meeting, the Board approved the Fresh Food Pathways pilot project plan and the budget amendment.

#### **Fiscal Note:**

\$962,618 in total is budgeted for the Fresh Food Pathways Program.

This project will utilize the balance of the budget from ARP2021x008 Emergency Food Assistance (\$212,618.12) and \$750,000 from ARP2021x016 Fresh Food Pathways broken out in the following manner:
