Second Amendment to Agreement with W.W. Gay Fire Protection, Inc. (13481), in the amount not to exceed (NTE) \$252,000.00, for Annual Fire Sprinklers, Risers, Extinguishers, Suppression Systems, and Alarm Panels Inspections, Maintenance and Repairs, for Facilities Management. This amendment extends the term and amends rate schedule.

Approve and authorize the Chair to execute the Second Amendment to Agreement with W.W. Gay Fire Protection, Inc. (13481), in the amount NTE \$252,000.00 annually.
