THIS SECOND AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and W. W. Gay Fire Protection, Inc., a Florida for profit corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Contractual Services Agreement dated 09/13/2022, for Annual Fire Sprinklers, Risers, Extinguishers, Suppression Systems, and Alarm Panels Inspections, Maintenance, and Repairs, identified by No. 13481 (the “Agreement”); and

**WHEREAS**, the Parties previously entered into a(n) amendment dated 06/29/2023, to renew the term of the original Agreement (the “First Amendment”); and

**WHEREAS**, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

**WHEREAS**, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

**NOW, THEREFORE**, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. Section #3, of the Agreement titled “*Term*” is amended to read as follows:
  - 3. **Term**. This Agreement is effective on October 1, 2022 (“effective date”) and continues until September 30, 2025, unless earlier terminated as provided herein.
- B. Amendment. Exhibit #2, titled “Rate Schedule” is amended in its entirety and attached to this Amendment.
- C. Effective Date. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2024.
- D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
