January 10, 2023, the Board approved the Award of Bid 23-56 Annual Purchase of Veterinary Medical Supplies, to B & R Supply, LLC, Covetrus North America, LLC, Hemera Holding, LLC, Midwest Veterinary Supply Inc., and MWI Veterinary Supply Co., for the purchase of veterinary medical supplies, for Animal Resources. Fiscal Note:

There are sufficient funds in the FY24 Animal Resources & Care Budget to cover the increase; however, the Donation Fund was added to the purchase order to cover the costs from this amendment.
