

RESOLUTION 24-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, TO RECOGNIZE UNANTICIPATED REVENUE FOR THE RECEIPT OF JUSTICE AND TREASURY FORFEITURE FUNDS, AUTHORIZE EXPENDITURES FROM SAID FUNDS, AND PROVIDE AN EFFECTIVE DATE.

WHEREAS, it is necessary to recognize unanticipated revenue for the receipt of funds associated with the Justice Forfeiture Fund (Fund157) and Treasury Forfeiture Fund (Fund 184) for the Sheriff; and,

WHEREAS, it is necessary to appropriate for expenditures associated with such funds;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

1. That the fiscal year 2024 budget is amended for the receipt of such funds as reflected in the budget amendment attached. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby appropriates and permits the expenditure of the funds described therein.
2. That this resolution shall take effect immediately upon its adoption.
