

**THIRD AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND
KRAUS ASSOCIATES INC., D/B/A AK ASSOCIATES NO. 11499**

THIS THIRD AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and AK ASSOCIATES INC, a Florida for Profit Corporation, which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the Parties previously entered into a Contractual Services Agreement dated January 14, 2020 for Maintenance and Services of Solacom Guardian Emergency Telephone System (the “Services”), identified by No. 11499 (the “Agreement”); and

WHEREAS, the Parties previously entered into the First Amendment to the Agreement, dated 29 March 2023, (the First Amendment); and

WHEREAS, the Parties previously entered into the Second Amendment to the Agreement, dated 13 August 2024, (the Second Amendment); and

WHEREAS, the Parties desire to amend the Agreement to include the annual cost for the servicers for the year October 1 2024 through September 30, 2025.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Section 5 of the Agreement, Method of Payment, sub-sections 5.1 and 5.2 are amended to add the annual costs for Year six, with one percent (1%) annual increases, October 1, 2024 through September 30, 2025 amended to read as follows,

5.1. Annual Contract amount for on-site support three days a week in accordance with the Scope of Service, Exhibit "I". The Parties agree that subsequent automatic renewals shall include a 1% price increase

5.2. Annual Contract amount for on-site support if it is reduced to, two days a week in accordance with the Scope of Service, Exhibit "I" The Parties agree that subsequent automatic renewals shall include a 1% price increase

B. Effective Date. This Amendment shall be effective October 1, 2024 after full execution of this Amendment by the Parties.

C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
