## SECOND AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND KRAUS ASSOCIATES INC., D/B/A AK ASSOCIATES NO. 11499

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision, and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and AK ASSOCIATES INC, a Florida for Profit Corporation, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

#### WITNESSETH:

WHEREAS, the Parties previously entered into a Contractual Services Agreement dated January 14, 2020 for Maintenance and Services of Solacom Guardian Emergency Telephone Systems (the "Services), identified by No. 11499 (the "Agreement"); and

WHEREAS, the Parties previously entered into the First Amendment to the Agreement, dated March 29, 2023, (the "First Amendment); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

**WHEREAS**, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #2, of the Agreement titled "Term" sub-section 2.1 is amended to read as follows:
  - 2.1. This agreement is effective upon execution by both Parties continuing through September 30, 2025, unless earlier terminated as provided herein. This Agreement shall automatically renew for additional one (1) year periods at the same terms and conditions outlined herein unless either Party provide notice of the intent not to renew no less that 120 days prior to the expiration of any term.
- B. Effective Date. This Amendment shall be effective upon execution by both Parties
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
