FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND KRAUS ASSOCIATES INC., D/B/A AK ASSOCIATES NO. 11499

THIS First AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and AK ASSOCIATES INC, a Florida for Profit Corporation, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS the Parties previously entered into a Contractual Services Agreement dated January 14, 2020 for Maintenance and Services of Solacom Guardian Emergency Telephone System (the "Services"), identified by No. 11499 (the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to allow the Contractor to furnish the goods or service to Alachua County and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Exhibit 1, of the Agreement titled "Scope of Service" is amended to add subsections 1.1.10 to read as follows:
- 1.1.10 As enhancements and various solutions are added by Solacom to the Solacom Guardian emergency telephone system offered through AK Associates, AK Associates will provide its services for implementation of these enhancements under its current maintenance service agreement with Alachua County. The enhancements may include text to and from 911; management information services (MIS) for 911 call statistics; and live streaming video.
- B. <u>Amendment.</u> Section 5 of the Agreement, Method of Payment, is amended with the addition of a new sub-section 5.3 to read as follows,
 - 5.3 In accordance with Exhibit 1, in the event the Contractor is requested to modify, move, configure, install, upgrade or procure equipment or services for the County to enhance the Solacom Guardian emergency telephone system, the County shall pay the Contractor an amount not to exceed \$750,000.00 for each iteration of services or equipment.
- C. <u>Amendment.</u> Section 5 of the Agreement, Method of Payment, is amended to reflect the current sub-sections 5.3 through 5.6 are re-numbed to be 5.4 through 5.6.
- D. <u>Effective Date</u>. This Amendment shall be effective upon and after full execution of this Amendment by the Parties.
