**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUE FOR THE EMPG FEDERAL GRANT; APPROPRIATING SAID FUNDS; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, it is necessary to recognize unanticipated revenue for the receipt of funds from the State of Florida, Division of Emergency Management; and,

**WHEREAS**, it is necessary to appropriate for expenditures associated with such funds to help fund a regional, State Grant Coordinator to assist counties in Northeast Florida, which helps enhance preparation, response and recovery from terrorist events that may occur within, or otherwise affect Alachua County

**WHEREAS**, the total grant award is \$84,604.62.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA;**

1. That the fiscal year 2024-2025 Adopted budget is hereby adjusted as reflected in the budget amendment attached hereto.
2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby accepts the EMPG grant revenue and appropriates and permits the expenditure of the funds described therein.
3. This resolution shall take effect immediately upon its adoption.
