I worked from 1999-2004 in a range of different services directly with survivors of sexual exploitation and trafficking, intimate partner and sexual violence. I completed a PhD on sexual exploitation and trafficking of young women in the UK. At UF I teach courses on Violence Against Women and Sexual Ethics, and liaise closely with workers from the rape crisis center on classroom and campus outreach. I was first appointed to this board in 2018, and re-appointed in 2021.

What Contributions do you feel you could make if you were selected to this board?

I value this work hugely and would welcome the opportunity to continue. I have experience of working with survivors of sexual violence, including on a hotline in the UK, and understand the importance of victim services and rape crisis work. Since 2018 I have worked closely with the rape crisis center to develop a research project exploring attrition of sexual battery reports in Alachua County. With a colleague at UF, I have now analyzed all sexual battery reports made to GPD from 2015-2018 and tracked the cases through to the State's Attorneys Office. This project is included in the current and new work plan for the Victim Services and Rape Crisis Center, so that its findings can be shared as part of improving responses for survivors of sexual assault. If I am able to continue on the Advisory Council, I can support the center to interpret and disseminate the findings to inform their

advocacy and community education work. I have also worked with the center on surveying staff members about policy and practice, offering my research skills to the center. Because I teach courses on sexual violence, I invite outreach workers from the rape crisis center into these courses; students have the opportunity to learn more about the work of the center and volunteer opportunities, building stronger connections between the center and campus community. I believe the advocates and workers are delivering essential support to survivors locally and would very much like to continue contributing to the board.
