FIRST AMENDMENT TO SUBRECIPIENT AGREEMENT BETWEEN ALACHUA COUNTY &MERIDIAN BEHAVIORAL HEALTHCARE ON CENTRAL RECEIVING SYSTEM NO. 13660

THIS First AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Meridian Behavioral Healthcare, Inc., a Florida not for profit corporation which is authorized to do business in the State of Florida ("Meridian"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement dated, December 20, 2022, for establishment of a central receiving system to provide behavioral health care, identified by No. 13660 (the "Agreement"); and

WHEREAS, the Parties desires to amend the Agreement to modify the dates for the final payment request and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. <u>Amendment</u>. Section #6, of the Agreement titled "ARPA Funding, Payments." is amended to read as follows:

Funding, Payments. Payment made under this Agreement shall be on a reimbursement basis. In order to obtain reimbursement payments, Meridian will have to submit request for payments in writing to the County and the County will require Meridian to provided supporting documentation with the request for payment and be subject to performance monitoring. Reimbursement requests may be submitted as frequently as monthly. Subject to receipt of proper supporting documentation from Meridian to the County with each request, payment by the County to Meridian shall be made within thirty (30) days of receipt. The County may deny a request for funding, in whole or in part, if the County determines that an expenditure is not eligible under the terms of this Agreement. Meridian is liable for re-payment to the County of any funds provided to Meridian or if any representation or supporting documentation is found by the County to be false or misleading or ineligible or not in compliance with the terms of this Agreement. The final request for payment is due on or before October 15, 2025, for costs incurred through September 30, 2025.

B. <u>Effective Date</u>. This Amendment shall be effective upon execution by both Parties.

C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
