Carolyn's Heart Incorporated

According to Alachua County data in 2022, 20.2% of the population lived below the poverty line, 16.2% being children, which is higher than the national average of 12.5%. Alachua County is home to a population of 280k people. 20% of the population was living with severe housing problems from 2014 to 2023. The average monthly income for a family of 3 living at 150% of the federal poverty level is \$3,227.00 The UF Shimberg Center for Housing Studies' most recent brief reported that 36% of Alachua County low-income renters put more than 40% of their income toward housing. "Affordable Housing" means that monthly rents or mortgage payments including taxes and insurance do not exceed 30 percent. We have families of three trying to provide for the basic needs of their family with \$1936.00 after paying rent. Based on this trend, it is getting harder for families to survive let alone thrive.

Housing instability and utility disconnections are critical issues that exacerbate poverty, Oftentimes families are unable to pay their rent or utilities and have to make hard decisions when it comes to caring for their family. Some families find themselves facing eviction and staring at the possibility of transitional homelessness, which is "a state of homelessness that's a result of a major life change or catastrophic events such as job loss, unexpected medical expenses or divorce. The Empower Stability program provides rental and utility assistance to alleviate the financial burden on low-income households with the goal of stabilizing housing and preventing utility disconnections. Financial literacy focusing on debt management will be a requirement to receive assistance. Clients will have to take a mandatory money management class to create an action plan to build a sustainable plan to care for their families.

Quantified Anticipated Benefits: Housing Stability: Prevent eviction for 50-75 households, approximately 225 individuals (assuming an average household size of 3) annually. Utility Access: Ensure continuous utility services for 50-75 households, improving their living conditions. Financial Literacy and Economic Self-Sufficiency: Train 100-250 households in financial literacy, focused on increasing budgeting and saving skills. Increase disposable income by implementing an effective budget and savings plan for 50 to 75 households, allowing for better allocation towards food, healthcare, and education.

Community Impact Corporation

Alachua County has seen an increase in persons needing housing, food and clothing due to increased homelessness and people living at or below the 150% Federal poverty Level. The Community Impact Corporation is proposing to use funds from this grant to provide food and clothing to individuals and families in need. We have served citizens throughout Alachua County since the year 2015. We operate a food give-away and clothing drive on Tuesdays with donations from churches and grocery stores. Bi-Monthly, we have been able to provide food from the Food Bank. This proposal is to expand the distribution of food to every Tuesday by securing funding to pay for food items every week so that there will be a guaranteed food supply available each week. We currently do not have the funds to pay for the Food Bank truck to come on a weekly basis. The funding received from this resource will allow us to meet the goal of serving those in need on a weekly basis. Since our facility is located in the Northeast section of Gainesville, we believe that we are positioned to be able to create a haven that assists with services that meet the needs of children, youth, adults and seniors to impact and enhance their lives. Our priority population is to serve individuals and families with lowincome who are marginalized and under-served, that need assistance by providing them food, clothing and resources to improve their lives. All services will be geared to serving those individuals and families that are at or below the 150% poverty level. Since the inception of the food and clothing giveaways, we have served more than 46,000 individuals and families, with over 150-200 being served each month. Our plan is to serve over 3300 individuals/families annually, serving 260 each month. Our process for providing these services will be to access qualifications and then provide the food and clothing on a first come first serve basis. All persons will receive a resource and referral list to assist them with other needs.

Ecology of the Heart

Ecology for the heart is a non profit that aims to provide educational services for students from extremely low income families. According to the 2022 census about 12.8% of families with children in Alachua county were below poverty level. The project would aim to have tutors and coaches for 5 to 10 students (depending on the budget) so that students can succeed academically and thrive in school life. We want to have tutors who not only teach but are also able to coach students so that they have the best possible access to education. We also aim to provide meals to the students who will be coming to the sessions. Currently we have one tutor but with this grant we hope to increase the number of tutors and students who will avail these services.

The anticipated benefits are:

Boost the students confidence and academic excellence

Around 5 to 10 students will get meals those days

Whatever the academic area student is weak in, they will have access to coaches help them grow in those areas

Students, in spite of challenges from other areas of their lives, will be able to keep up with academic life

First Missionary Baptist Church of Gainesvil

The First Missionary Baptist Church of Gainesville, INC's project proposal is for infrastructure/building and electrical circuit wiring renovations, to allow expanded access for our non-profit food outreach program, which currently benefits Gainesville residents from the lower income levels, where households struggle with food deficiencies. These households are already at or below the requisite poverty levels.

Quantify the Anticipated Benefits:

Currently the building infrastructure has older wiring infrastructure, which presents structural limitations to commercial type storage, needed to increase our nonprofit food outreach.

Current building use capacity for food storage outreach programs- Without Infrastructure Grant Upgrades: 6 to 8hours (due to electrical issues and necessary building improvements);

Newly Anticipated Building Infrastructure Capacity With 5K infrastructure SGI Grant Upgrades:

30 to 45 days of extended building utilization for outreach food storage (based on building wiring upgrade and infrastructure renovations to allow for commercial grade kitchen space with proper wiring capacity).

Florida Sickle Cell Center, Inc.

The purpose of this project, is to conduct a needs assessment to collect data and information to help identify the specific needs, barriers, and opportunities of individuals living with Sickle Cell. This will add to the previous healthcare data analysis that provided local, national, and global insights and a model of care that transformed the care of adult individuals living with Sickle Cell.

The intended outcome is to gain insights and understandings that will inform program quality: the development of a Sickle Cell Center and inform the quality care of approximately 500 individuals living with Sickle Cell Disease in Alachua and surrounding counties, who primarily live at or below 150% Federal Poverty Level as a consequence of their condition.

The Needs Assessments will involve three phases: Data Collection, Data Analysis, and Dissemination.

- 1. During Data Collection we will gather patient population information from local county data and administer the data collection tool. This allows for the collection of data and information directly from the patient population that the center will serve.
- 2. During Data Analysis we will conduct quantitative and qualitative data analysis and visualizations using statistical software. My master's in public health from the University of Florida is research and statistics based and I have a Statistics certificate from Harvard Medical School. Additionally, I have conducted research and written papers and reports in which I completed the Specialized training in trauma-informed care and financial literacy education analyses and visualizations which have been used locally, nationally, and globally to inform Sickle Cell care, making me an expert in Sickle Cell and Data Professional development for improved program delivery Analytics.
- 3. During Dissemination, as is the tradition and mission of the organization to increase access to quality care not just locally, but nationally and globally, we wish to share results and any findings and conclusions. We will share our results to the patient population and other stakeholders by posting on our website. It also allows for the patient informed development of the Sickle Cell center and strengthens funding requests for a very specialized service.

I will also reach out to sports groups where they can't have their kids play sports because they don't have affordable health care. I would like to reach at least 100-150 families.

Karre Beauty

In the past, Karré Beauty has proudly donated 10% of sales to charity and supported our community through food drives. Unfortunately, this summer has been challenging, and we haven't been able to generate the funds needed to continue these efforts.

We are currently working towards purchasing a trailer to become mobile for pop-up events. Our products are sensitive to heat, which has limited our ability to participate in outdoor events. By securing a trailer, we can attend more pop-ups, meet our budget goals, and once again contribute to our community through food drives and other charitable activities.

Krishna House North America

For the past several years we have been an informal way been feeding several people in need in the Alachua area. Recently we founded Krishna House North America to expand not only our food distribution to those in need but all over the US and Canada where we have several connected soup kitchens. The project aims to feed the homeless, homebound, elderly, disabled and whoever is in need. We are currently doing about 50 meals daily and hope to increase that number. To that extent we are planning to help expand the current kitchen we use at Krishna House in Gainesville. Installing a commercial hood will mean being able to cook more and serve more people for years to come. We had fundraised about \$50,000 and a good chunk of it has been used to do repairs, we now need to raise more to put the final piece of the kitchen expansion: commercial hood and fire suppression system. We have pledges from donors and donations left to complete this estimated \$60,000 to \$70,000 project esp with the help of the SGI grant.

With the increased cooking capacity we hope to be able to feed even more people who are below poverty level.

This will include upgrading our kitchen so that we can Provide Nutritious Meals and snacks for the children and families in our care and successfully structure our business which includes hiring an accountant and a professional payroll agency so that we can ensure our longevity in the community as a top tier childcare learning facility that serve low-income families.

The Black On Black Crime Task Force

The Project, Baxter Place, is an after-school enrichment program designed to serve male middle school students from Alachua County. Our primary goal is to assist this population. According to our local Department of Juvenile Justice statistics, there were 818 total arrests of juveniles in Alachua County in 2023; male youth made up five hundred ninety-one of these arrests, and males of color made up 471 of the total arrests. Addressing these disparities involves systemic changes, community engagement, and targeted interventions. Recognizing and challenging these factors is crucial for promoting equity and reducing the disproportionate involvement of minority youth in the criminal justice system. Our goal at Baxter's Place is to provide aftercare components for youth who meet the federal poverty level by providing these youth with academic enrichment activities by certified teachers from Alachua County. We plan to transport the selected child to our sits on a large plot with a spacious backyard, offering a multitude of uses. The facility, where the youth will engage in educational activities through social and emotional learning. Supporting the social and emotional development of male middle school students, especially those facing economic challenges, is essential to the youth's overall well-being. The youth will engage in exercises such as the circle of control, where they learn the difference between things within their control. They will explore the connection between thoughts, Time Management, Empathy Building, positive affirmation, and conflict resolution. In addition, the youth will have a meal to fellowship with each other and meet their needs. The youth will be transported to their residence at the day's conclusion.

The Dunbar LLC

The proposed project involves the revitalization of The Dunbar Hotel, historically known as the only hotel in Gainesville, Florida, that accepted Black patrons during the segregation era. It served as a significant cultural hub, welcoming both famous Black musicians like Duke Ellington, B.B. King, and Ella Fitzgerald, as well as local workers such as strawberry pickers and vegetable farmers. The project aims to reopen The Dunbar as a restaurant and community space, drawing inspiration from its historical significance.

The hotel currently has 10 rooms with communal bath and shower facilities, but we plan to downsize to 5-7 uniquely designed rooms, each with private bathrooms. The restaurant will offer a gourmet dining experience inspired by local cuisine, Gainesville dishes, and flavors from past travels. The building courtyard will extend the dining area, hosting events such as private birthdays, dinners, cookbook clubs, weddings, yard sales, and community gatherings. Additionally, we plan to establish a free community library for children and book lovers, as well as a free food pantry offering bread, pasta, canned goods, and other essentials year-round.

Mental health and wellness services will be offered through health clinics, conflict resolution workshops, and recreational activities. The YAB will also engage in policy advocacy, developing and presenting policy proposals, and collaborating with advocacy groups. Data collection efforts will involve conducting surveys and research projects, while resource development will include creating and distributing resource guides and maintaining a mobile app (Eventbrite/Gator programs. The anticipated benefits include reaching approximately 2.500 youth annually through various initiatives, providing educational and career development opportunities to 600 youth, and improving housing stability and health outcomes for 1,000 youth, thereby enhancing the overall support system for disadvantaged youth in Alachua County.
