The proposed project aims to significantly empower the Youth Action Board (YAB) to lead initiatives that address the needs of residents of Alachua County living at or below 150% of the Federal Poverty Level by significantly reducing gun violence and youth homelessness in Alachua County. This project will focus on advocacy, peer support, community engagement, education, housing, health, policy change, data collection, and resource development. Key activities include organizing awareness workshops and social media campaigns to educate about homelessness, establish peer mentorship and support groups, and facilitate community clean-up events and volunteer opportunities. Educational support will be provided through tutoring programs, career workshops, and partnerships with local businesses to create apprenticeships. Housing solutions will include host home programs, shared housing initiatives, and advocacy for transitional housing. Mental health and wellness services will be offered through health clinics, conflict resolution workshops, and recreational activities. The YAB will also engage in policy advocacy, developing and presenting policy proposals, and collaborating with advocacy groups. Data collection efforts will involve conducting surveys and research projects, while resource development will include creating and distributing resource guides and maintaining a mobile app (Eventbrite/Gator Safe). Feedback mechanisms will ensure continuous improvement of programs. The anticipated benefits include reaching approximately 2,500 youth annually through various initiatives, providing educational and career development opportunities to 600 youth, and improving housing stability and health outcomes for 1,000 youth, thereby enhancing the overall support system for disadvantaged youth in Alachua County.

The proposed project aims to significantly reduce gun violence and youth homelessness in Alachua County, specifically targeting residents living at or below 150% of the Federal Poverty Level. The project will yield measurable outcomes across several key areas. First, we aim to secure stable housing for 200 youth annually through host home programs, shared housing initiatives, and transitional housing, while preventing homelessness for 150 at-risk youth through early intervention and support services. To combat gun violence, we plan to reach 1,500 youth annually with awareness and education initiatives, including workshops, social media campaigns, and public speaking events, and engage 600 youth in positive activities such as community engagement projects and volunteer opportunities. In terms of educational and career outcomes, we will provide support to 300 youth annually, aiming for 80% academic improvement, and enroll 200 youth in job training programs, placing 100 youth in jobs or apprenticeships. To enhance health and wellness, we will offer services to 400 youth annually, with 70% of participants reporting improved mental health through peer support groups and mental health services. We will also train and engage 10 youth leaders annually through the Youth Action Board and develop and present 5 policy proposals, with at least 2 resulting in policy changes. Effective data collection will involve gathering information from 500 youth annually to inform program

improvements, while feedback mechanisms will lead to 12 program enhancements each year. Lastly, we will distribute 1,000 resource guides annually to ensure youth can easily access the services they need. By achieving these outcomes, the project will demonstrate its success in addressing critical issues, improving educational and career opportunities, enhancing health and wellness, fostering youth leadership, and ensuring effective service delivery in Alachua County.
