As the Criminal Investigations Division Commander from January 2022 to June 2023, I provided effective leadership to a division of 54 positions, overseeing squads dedicated to investigating a range of cases, including sexual assault. My responsibilities included daily supervision, critical incident response, training coordination, and collaboration with external entities to enhance the division's crime investigation capabilities. Notably, I actively participated in complex investigations, such as sexual assault cases, and engaged in multidisciplinary team meetings to improve responses to sexual assault, human trafficking, and child abuse in the community. Additionally, I played a key role in transitioning the department to a trauma-informed approach for all police interactions and investigations, with a specific focus on sexual assault cases. My commitment to improving outcomes for victims was further demonstrated through mentoring and developing officers, as well as delivering trauma-informed interviews to victims and witnesses. During my tenure as Detective Sergeant from November 2013 to September 2017, I supervised a team dedicated to investigating adult sexual violence, child kidnapping, and other related crimes. My contributions included overseeing the North Florida Internet Crimes Against Children (ICAC) Task Force, implementing a trauma-informed approach to sexual assault investigations, and collaborating with external organizations. I actively conducted investigations, delivered training, and participated in multidisciplinary team meetings to enhance the community's response to sexual assault and related crimes. In addition to my extensive law enforcement experience, I have been actively involved as a Trainer/Consultant for the Florida Council Against Sexual Violence since October 2017. In this capacity, I contribute to the development of training materials, design curriculum, and deliver trauma-informed sexual assault investigations training to various professionals, including law enforcement, medical personnel, victim advocates, and legal professionals. I also play a key role in creating and presenting "Train the Trainer" programs for trauma-informed sexual assault investigations. As an Adjunct Instructor at Santa Fe College since August 2018, I educate both basic recruits in the police academy and current sworn law enforcement officers on topics such as domestic violence, elderly abuse/exploitation, sexual violence, trauma-informed investigations, and officer mental health.
