Description:

First Amendment to Agreement with Monday.com LTS. (14179), in the amount of \$377,946.00, for a three-year renewal of Monday.com Enterprise Plan with Information & Telecom Services. This amendment extends the term starting January 30, 2025, through January 29, 2028.

Recommended Action:

Approve and authorize the Chair to execute the First Amendment to Agreement with Monday.com LTS (14179).

Prior Board Motions:

February 27, 2024, the Board approved and authorized the Chair to execute the Single Source and Agreement 14179 with Monday.com LTS., in the amount of \$86,400.00.

February 28, 2023, Board approved the issuance of Purchase Order 23-1603 to SHI International Corp, in the amount of \$82,203.00, for the renewal of Monday.com for Information & Telcom Services. Item 23-0455.

January 25, 2022, Board approved Purchase Order 22-1485 to SHI International Corp, for the renewal of Monday.com and waived the standard indemnification requirements in County Resolution 14-33. Item 22-0081.

February 23, 2021, Board approved a purchase order to SHI International Corp, for the renewal for Monday.com and waived the standard indemnification requirements in County Resolution 14-33. Item 21-0118.

Background:

The attached Single Source and SaaS (Software as a Service) Agreement provides for a total of 450 licenses. The quote is based on a Single Source Agreement between Alachua County and Monday.com. Previously, we had renewed Monday.com through SHI but moved the agreement to work directly with Monday.com in order to take continued advantage of discount deals.

With the increase in demand for collecting, organizing, managing and sharing information from numerous sources, so has there been an increase in demand for a tool to efficiently and effectively achieve those objectives. Monday.com is currently used by Emergency Management, Fire Rescue, Budget and Fiscal Services, County Attorney, EPD, HR, and ITS to quickly and effectively collaborate between themselves and several partner agencies throughout the county.

This purchase is exempt from the County's competitive bidding requirements pursuant to Section 22.3-302 (27) of the Alachua County Procurement Code, Single Source procurements in accordance with the Procurement Procedures Manual; however, since the dollar amount of the purchase exceeds the purchasing authority of the Procurement Manager, this is being submitted for Board consideration and approval.
