The First Missionary Baptist Church of Gainesville, INC's project proposal is for infrastructure/building and electrical circuit wiring renovations, to allow expanded access for our non-profit food outreach program, which currently benefits Gainesville residents from the lower income levels, where households struggle with food deficiencies. These households are already at or below the requisite poverty levels.

Quantify the Anticipated Benefits:

Currently the building infrastructure has older wiring infrastructure, which presents structural limitations to commercial type storage, needed to increase our nonprofit food outreach.

Current building use capacity for food storage outreach programs- Without Infrastructure Grant Upgrades: 6 to 8hours (due to electrical issues and necessary building improvements);

Newly Anticipated Building Infrastructure Capacity With 5K infrastructure SGI Grant Upgrades:

30 to 45 days of extended building utilization for outreach food storage (based on building wiring upgrade and infrastructure renovations to allow for commercial grade kitchen space with proper wiring capacity).

With proper building wiring and kitchen area expansion, the Food Outreach Program will be able to:

- expand the dates of deliver to outreach services to offer more to community members,

30 Day Measurables: Within the first 30 days, we will measure the anticipated increase in the number of individuals served via our Food Ministry. On average we have served between 30-50 individuals...we anticipate an increase of 50-100 individuals due to the fact we will have the capacity to store and house more food via our new commercial freezer and refrigerator. This allows for more fruits, vegetables, and meats to be served via this ministry. Additionally, those who arrive may be served faster due to the newly upgraded facility which will allow for drive up outreach services thru the building's anticipated new drive up lane and newly constructed weather protection outdoor awning; this service would not be possible with the building SGI grant.
