The first step (2 months) would be to ensure our building is up to code, this would include fixing of the church's current roofing structure. We obtained two quotes to fix the roofing. One of the quotes is for shingle roofing materials (not including labor) at \$8,795.52

The other quote is for metal roofing materials (not including labor) at \$11,614.30

The next step (2 months)would be to work together with <u>(QRIS) National Accreditation</u> to ensure that all safety measures and precautions are up to par in our current structural buildings where we would place the daycare.

Following Step (1 month) would be to train the volunteers that would be helping the various roles within the daycare: i.e, staff, teachers, cooks, etc.

Final Step (1month) would be promoting of the daycare within the nearby communities: door to door, flyers, online promotions, social media marketing.
