# FIRST AMENDMENT TO ADDENDUM AGREEMENT BETWEEN ALACHUA COUNTY AND LEXIPOL LLC, NO. 13154

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Lexipol, a Foreign Limited Liability Company which is authorized to do business in the State of Florida ("Lexipol"), who are collectively referred to as the "Parties".

#### WITNESSETH:

**WHEREAS**, the Parties previously entered into an Agreement, dated December 14, 2021, for Fire Rescue Training Materials and Services identified by No. 13154 (the "Agreement"); and

WHEREAS, the Agreement has a term which ends December 31, 2024, and the County has elected to renew the term of the Agreement to allow the Lexipol to furnish the goods or service to Alachua County; and

**WHEREAS**, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #3.a, of the Agreement titled "Term" is amended in its entirety to read as follows:
  - i. This Amendment extends the term of the Agreement for a period of three years commencing January 1, 2025, after execution by both Parties and continues through December 31, 2027, unless earlier terminated as contained herein
- B. <u>Amendment</u>. Section #3.b, of the Agreement titled "Term" is amended by the addition of subsection ii to read as follows:
  - ii. i. LEXIPOL shall be paid a sum Not to Exceed \$100,721.21, for the three-year renewal term of this Agreement based for the services in Attachment 1A, attached to this Amendment, payable in the following manner:

- C. Amendment. Section #3.f, of the Agreement titled "Human Trafficking Affidavit of No Coercion for Labor or Services" is added and reads as follows:
  - f. Human Trafficking Affidavit of No Coercion for Labor or Services

- i. Section 787.06(13), Florida Statutes, requires any governmental entity, which includes "district", when executing, renewing, or extending a contract, must obtain an affidavit from the non-governmental entity attesting that it does not use coercion for labor or services. The terms "coercion" and "labor" are defined respectively in sections 787.06(2)(a) 1-72 and 787.06(2)(e)3, Florida Statutes.
- ii. Lexipol will certify this understanding, obligation, through the completion of the No Coercion for Labor or Services Affidavit, a copy of which is attached the this Amendment as **Attachment "2"**
- D. <u>Effective Date</u>. This Amendment shall be effective upon execution by both Parties.
- E. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
