Subject:	Transportation Improvement Program Amendment – 5310 Operating Assistance			

RECOMMENDATION

It is recommended that the Metropolitan Transportation Planning Organization amend its Fiscal Years 2024-25 to 2028-29 Transportation Improvement Program to include 5310 Operating/Administrative Assistance for Gainesville's Regional Transit System.

BACKGROUND

The Florida Department of Transportation has requested that the Metropolitan Transportation Planning Organization amend its Fiscal Years 2024-25 to 2028-29 Transportation Improvement Program (TIP) to include \$200,000 in FY2025 in Federal Transit Administration Section (FTA) 5310 Operating/Administrative Assistance for Gainesville's Regional Transit System. The FTA 5310 program provides formula funding to states and designated recipients to meet the transportation needs of older adults and people with disabilities.

For these funds to be expended, the Metropolitan Transportation Planning Organization needs to modify its Fiscal Years 2024-25 to 2028-29 Transportation Improvement Program to add this project in the current year of the TIP. This item is appearing before the MTPO Board for action. The request from FDOT is attached.
