As requested, please see the explanations below.

Operating expense when it comes to “Camp Expenses” are expenses related to running the camp while the camp season is active for 7-8 weeks a year. These items include, but are not limited to, the purchase of training courses for the camp counselors, memberships with camp-related organizations, or bus rentals provided by Alachua County’s School Board for the transportation of camp participants to and from camp.

The remaining operating expenses are for Cuscowilla to maintain the grounds all year-long, and are not tied to just the camp season. These would include, and are also not limited to, items such as utilities, vehicles, equipment, repair and maintenance, water testing, trainings, and/or cleaning services.
