6) Property Evaluations – Staff Presentations

a) East Newnan's Lake – Putz - Property presented by Matt Barker

Nominated by owner as a fee simple acquisition
Property owner, Jack Putz, was present and stated the value in the land is in
location and variety of ecosystems present. He expressed he would like to see
more of the Zetrouer land in the area protected. Stated old growth cypress is
present. A fallen slash pine was dated about 190 years old. Several old slash
pine cohorts are present. Spotted 18 eagles at one time in the past. Five
distinctive ecosystems are present, which has made the property ideal for
research. Has been controlling air potato.

Access to the property is a deeded easement. Potential public accessibility is unknown.

Motion was made Amy Schwarzer to place the East Newnan's Lake – Putz property into the eligibility pool. Ed Hunter seconded the motion. Motion passed with a vote of 11-0.

Lochloosa Creek Flatwood-Little Orange Creek Investors LLC was previously placed in the eligibility pool by the LCB. The property was brought back for consideration by request of the LCB after an adjoining parcel was placed in the priority pool. The board discussed the property being within a newly designated state wildlife corridor and implications for funding, connections to other parcels,

recreation possibilities, management of invasive plants, and the condition of the property.

Motion was made by Kristen Young to place Lochloosa Creek Flatwoods- Little Orange Creek Investors LLC in the priority pool contingent on a contract with Lakes of Hawthorne parcel. Ed Hunter seconded the motion. Motion passed with a vote of 11-0.
