Background:

The work generally consists of preparing the site to accept concrete, placing, and finishing concrete, and returning the site to its original or better condition once work is completed. Work shall also include restoration and sodding of disturbed areas. Contractor shall provide all materials, labor, supervision, tools, accessories, equipment, permits, fees, testing, inspections, certifications, and all other things necessary for Contractor to complete concrete repair projects requested by the County.

All work specified shall be performed in accordance with the FDOT Standard Plans, current edition, and the FDOT Standard Specifications for Road and Bridge Construction, current edition, except as provided for in the attached document "Annual Concrete Construction & Repair Technical Specifications." Deviation from these standards will be permitted only upon presentation of specific written authorization by the County.

BID 25-33-LC Annual Concrete Construction & Repair Services was released on May 22, 2024. The deadline for receipt of BID 25-33-LC Annual Concrete Construction & Repair Services was June 26, 2024. BID 25-33-LC Annual Concrete Construction & Repair Services was rejected on July 30, 2024 due to the submittals not being in compliance with the Department's bid documents and instructions.
