Self-Insurance Letter - City of Gainesville and Gainesville Regional Utilities

Fiscal Year October 1, 2024 - September 30, 2025

State of Florida Self-Insurance Number – SXP3584002

To Whom It May Concern:

The City of Gainesville and Gainesville Regional Utilities utilizes a modified self-insured program for protecting itself against losses. The City of Gainesville is self-insured for both automobile and general liability losses subject to the sovereign immunity limits set forth in Florida Statute 768.28. The limits for claims incurred after October 1, 2011 are \$200,000 per person and \$300,000 per incident.

Gainesville Regional Utility's operations are covered with primary and excess general liability policies purchased through the City insurance broker to comply with contract and regulatory requirements.

The worker's compensation program consists of a self-insurance retention (SIR) of \$350,000 per claim with an excess worker's compensation policy covering any amount over the SIR.

The City's property is insured by Property, Boiler and Machinery Coverage and auto physical damage coverage purchased through the City's insurance broker.
