RESOLUTION 25-

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AUTHORIZING THE ACCEPTANCE OF A PUBLIC ACCESS EASEMENT FOR A PORTION OF PROPERTY IDENTIFIED AS TAX PARCEL NUMBER 07065-000-000, ALACHUA COUNTY, FLORIDA; AUTHORIZING THE EXECUTION OF DOCUMENTS TO EFFECTUATE THE ACQUISITION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, T Parklane Land FL, LLC ("Developer") filed an application for Minor Change to a Planned Development (PD) and Final Development Plan for Park Lane PD Phase IIA, a 176-unit multi-family residential development located at 7804 SW Archer Road on Tax Parcel No 07065-000-000 in Alachua County, Florida; and

WHEREAS, the Development Review Committee approved the application with conditions by issuance of Development Review Order DR-22-31 (the "Approval"); and

WHEREAS, condition 1 of the Approval requires the Developer to grant the County a public access easement across all private streets in Park Lane Planned Development Phase IIA, which includes the drive aisles, the angled parking and sidewalks; and

WHEREAS, the Developer represents and warrants to the County that the Developer is the owner of the real property otherwise known as Tax Parcel Number 07065-000-000 and, in accordance with condition 1 of the Approval, the Developer has executed a public access easement in favor of the County over all private streets, angled parking, and sidewalks within Park Lane PD Phase IIA; and

WHEREAS, the Board finds that accepting the public access easement from the Developer is in the public interest and satisfies condition 1 of the Approval; and

WHEREAS, nothing herein shall be construed to satisfy, waive or release the Developer's obligations regarding any other condition imposed by the Approval.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA;

- 1. The Board hereby accepts the Public Access Easement attached hereto as **Exhibit A.**
- 2. The Chairman and the Clerk of the Board are authorized to execute the Public Access Easement for the purpose of indicating the County's acceptance of same, and any other documents approved by the County Attorney needed to complete this conveyance.

- 3. The Board directs the County Manager to cause the executed and accepted Public Access Easement to be recorded in the public records of Alachua County, Florida, as soon as is reasonably possible after the adoption of this resolution.
- 4. This resolution shall take effect immediately upon its adoption.
