Section 3 – References and Experience:

1. For more than a decade, I have worked as a paralegal and office manager for a law firm practicing primarily in the areas of family, dependency, and criminal defense. Our legal systems are well-intended but ultimately incapable of fully addressing the core issues affecting youth in Alachua County. Courts are unfortunately more suited to addressing the symptoms of a problem, rather than the problem itself. I have seen and worked in too many cases where early intervention with a child could have radically altered the eventual adverse outcome or experience for a child. An educational opportunity, or access to more or better public health resources (including, or perhaps most especially, mental health resources), or an economic opportunity could have saved both the child and society enormous cost. The issue, it seems, is how to allocate scarce societal resources in the most efficient manner possible to make these interventions available to any youth in our community who needs or wants it. This is my understanding of the Trust's core mission. For more than a decade, I have been witness to some difficult endings. That goes with the job, and I'm not ready to give that up — after all, we fight the good fight, and I have gained valuable insight and perspective. But I very much think it is time for me to start working with my community to forge some good beginnings, too.

Government cannot, and should not, be doing this on its own. Solutions are, and must be, found or created with an emphasis on engagement of community stakeholders, and forging public-private partnerships. My education has focused on these very things. In December 2024, I completed my Master of Public Administration from Florida State University. My coursework and writings had a significant emphasis on community engagement and public-private partnerships. I thus have a background in both private enterprise (i.e., helping to run a small business), and public administration. I hope to bring both of these perspectives to my work with the Trust.

2. Unwavering commitment, reliability, and hard work, to put it simply. But I do not intend to be someone who walks in on Day One with preconceived notions of how the job must be done. I recognize that I am younger than the usual applicant. I intend to listen, and watch, and learn. When appropriate, I will offer my perspective and my ideas. I will be available to assist however I am asked, and to lead whenever the opportunity presents itself.

My relative youth is also something of value I believe I would bring to the Trust. I straddle the divide between Millennials and Gen Z, with perhaps both having a valid claim to me. It appears that if selected, I would be the youngest member of the Board. I am not a kid any longer, but I am closer to it than many. While I had a relatively carefree and easy upbringing, I am close with many peers who cannot say the same — and are now dealing with chronic

difficult issues adversely affecting them and their families in what should be the flower of their adulthood. This perspective is important to the Board's work, I think, and I would welcome the opportunity to present it.

3. I am employed as an office manager and paralegal at a law firm which practices family law and criminal defense. My supervising attorney previously had a contract with the Justice Administrative Commission (JAC) to provide representation to indigent defendants in criminal and juvenile delinquency cases. He declined to renew that contract in 2019, after personnel changes in our office. However, at the present time, my supervising attorney has accepted an appointment to serve as defense counsel for a co-defendant in one major felony case. We regularly sign and/or authorize invoices to JAC for direct reimbursement to court reporters, and the firm expects to receive from JAC a flat fee of \$6,000.00 - \$9,000.00 at the completion of the case.
