

**FIRST AMENDMENT TO AGREEMENT
FOR FLEET BUILDING SIDING REPLACEMENT WITH JH CONSTRUCTION, LLC
NO. (#)14369**

THIS FIRST AMENDMENT to Agreement (“First Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Joseph Hoffman Construction LLC, DBA JH Construction LLC, a Florida limited liability corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the County and Contractor previously entered into a(n) Contractual Services Agreement dated 10/09/2024 for replacement of up to two (2) damaged roll-up door jambs and headers and four (4) pane windows at the Fleet Management Building located in Alachua County Public Works Department, identified by No. 14369 (the “Agreement”); and

WHEREAS, the Parties desire to increase the contract amount and expand the Scope of the original Agreement to allow the Contractor to furnish, construct and install three steel canopies at the Fleet Management Building.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. Sub-Section #5.A, of the Agreement titled “Payment” is amended to read as follows:
 - A. For completion of all Work in accordance with this Agreement, Contractor shall be paid the sum of Seventy-Eight Thousand, Six Hundred Dollars and Zero Cents (\$78,600.00) (the “Contract Amount”), allocated as provided in the Schedule of Values, attached hereto and incorporated by reference as **Exhibit 2-1** attached hereto and incorporated herein.
- B. Amendment. Exhibit 1 to the Agreement, titled “Scope of Services/Work,” is amended to add the following new sub-section:
 - 1.6 Install a 20'x12' steel canopy over the tire and oil holding area and two 5'x4' canopies over exterior walk doors on the front of the building.
- C. Amendment. Price Tables, of Exhibit 2 to the Agreement, titled “Rate Schedule,” is amended in its entirety and replaced with Exhibit 2-1 of this First Amendment.
- D. Effective Date. This First Amendment shall be effective upon execution by both Parties.
- E. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties shall be and remain in full force and effect.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Alachua County (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact Alachua County:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from Alachua County

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to mguidry@alachuacounty.us and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with Alachua County

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to mguidry@alachuacounty.us and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software

Acknowledging your access and consent to receive and sign documents electronically
