Also, Fiscal Services is requesting approval of Budget Amendment to move the funds.

Fiscal Note:

Dash Cameras and GPS modules will be installed for All County Departments and Divisions with a phased approach with the initial installations starting with Fire Resue, Public Works, Solid Waste and Risk. There are sufficient funds available in the Risk Management reserves to cover this expense.

Background:

Alachua County solicited proposals from qualified vendors for the supply and installation of dash cameras in government vehicles. The dash cameras should include front-facing, rear view and in-cab

cameras, along with installation services and training. The not to exceed amount is \$1,013,440.50, (first year \$458,580.50 and second year \$554,860.00) for RFP 24-487-LC Dash Camera Installation and Services for Fleet Vehicles.

RFP 24-487-LC Dash Cameras Installation and Services for Fleet Vehicles released May 8, 2024. The deadline for receipt of RFP 24-487-LC Dash Cameras Installation and Services for Fleet Vehicles was June 26, 2024; five (5) vendors responded.
