Community Resource Center- Deeper Purpose Community Church

Description:

Alachua County Community Support Services has identified Deeper Purpose Community Church as a potential community resource center in support of improving access for social services to individuals who live in High Springs and the surrounding rural communities such as Newberry and Alachua. At the direction of the Alachua County Board of County Commissioners staff conducted a survey of Deeper Purpose Community Church to learn more about services provided.

On December 10. 2024, On December 10, 2024, the Alachua County Board of County Commissioners (BoCC) held a discussion regarding community centers as it relates to financial difficulties. The Commissioners elected to have a broad discussion regarding community centers in Alachua County. Below is the Commission motion.

Motion: Commissioner Prizzia stated that she would like to discuss community centers in a broad conversation as several of them are struggling in the current economy rather than just discussing the need in High Springs. She would like to discuss this at a Policy Meeting.

County Manager Lieberman stated that a Comprehensive discussion of Community Centers will be

County Manager Lieberman stated that a Comprehensive discussion of Community Centers will be scheduled for March with the appropriate staff.

The Department of Community Support Services created a needs-based survey to assess the status of community centers across the County. Deeper Purpose Community Church completed the survey.

On April 1, 2025, Community Support Services presented the findings of the survey of all respondents including Deeper Purpose Community Church.

Commissioner Cornell moved the following:

- 1. That staff identify for the Commission of the list which of these entities are municipally run versus run by nonprofits and/or volunteers, 501c(3) and provide that back to the Commission by email is fine.
- 2. Request any operating budgets that May or May not exist relating to these entities and provide that back to the Commission by email is fine.

- 5. Explore opportunities to utilize surplus and government access to resources and software for support of these centers.
- 6. Bring back recommendations for support of a community-wide resource guide that works.

The motion carried 5-0.

Subsequently, on May 5, 2025, Community Support Services met with Pastor Adam Joy, of Deeper Purpose Community Church to discuss his survey results which will be included in an update to the BoCC at a future meeting.

Since the initial survey, Community Support Services has held one additional meeting with Pastor Adam Joy, Founder and Pastor, to discuss survey responses and to determine needs. According to survey results and Pastor Joy, the church would like to expand its outreach and requests unspecified funding to achieve its goals. At the current time, the church offers some assistance in the areas of financial assistance in paying rent and utilities, gently used clothing, food assistance, and transportation to elderly residents.
