1. Alachua County, Plaintiff vs. Jordan Cash, Defendant <u>Case #: Not yet filed.</u>

The County Attorney seeks authority to initiate a small claims action against former Alachua County Fire Rescue employee Jordan Cash. During Mr. Cash's employment, Alachua County paid his tuition to attend a certification course related to his position. In exchange, Mr. Cash committed to remain an active employee of Alachua County Fire Rescue for at least two years after receiving his certification. Mr. Cash agreed in writing to repay, on a pro rata basis, the tuition costs if he failed to remain an employee of Alachua County for the duration of those specified timeframes. Mr. Cash had not fulfilled the two-year employment commitment at the time of his separation from Alachua County. In addition to tuition costs, Mr. Cash failed to turn in specific uniform items to Alachua County Fire Rescue when he left, although he was required to do so. Mr. Cash currently owes Alachua County a total of \$2,671.86 (\$2,222.76 tuition costs and \$449.10 for uniform items). Alachua County has made efforts to collect, with no results.

During Mr. Lindsey's employment, Alachua County paid his tuition to attend a certification course related to his position. In exchange, Mr. Lindsey committed to remain an active employee of Alachua County Fire Rescue for at least two years after receiving his certification. Mr. Lindsey agreed in writing to repay, on a pro rata basis, the tuition costs if he failed to remain an employee of Alachua County for the duration of those specified timeframes. Mr. Lindsey had not fulfilled the two-year employment commitment at the time of his separation from Alachua County. Mr. Lindsey currently owes Alachua County a total of \$3,734.47 for tuition costs. Ms. Roman had not fulfilled the aforementioned two-year employment commitment at the time of her separation from Alachua County, and currently owes Alachua County a total of \$1,246.60. Mr. Russell had not fulfilled the two-year employment commitment at the time of his separation from Alachua County. In addition, Mr. Russell was required to turn in all uniform items issued to him by Alachua County Fire Rescue when his employment ended. Mr. Russell failed to do so.
