

**SECOND AMENDMENT TO AGREEMENT
FOR ANNUAL TEMPORARY PERSONNEL SERVICES RFP-22-21, NO. 12029**

THIS SECOND AMENDMENT TO AGREEMENT is by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and CAREER CENTER, INC. d/b/a SPHERION STAFFING LLC, a Franchise Affiliate of RANDSTAD NORTH AMERICA, INC., hereinafter referred to as "Contractor". Collectively, the County and the Contractor are hereinafter referred to as the "Parties".

WITNESSETH:

WHEREAS, Alachua County and Career Center, Inc. entered into the *Agreement No. 12029 between Alachua County and Career Center, Inc. d/b/a Tempforce for Annual Temporary Personnel Services RFP-22-21*, dated August 4, 2021 (the "Agreement"); and

WHEREAS, the Parties entered into the First Amendment to the Agreement for the County to recognize and accept the assignment of the Agreement and re-designation of Tempforce to Spherion Staffing, LLC and to update and clarify other provisions; and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Section #1, of the Agreement titled "Term" subsection 1.1 is amended to read as follows:

1.1 Upon execution of this Amendment by both Parties the term of this Agreement is extended through September 30, 2025, unless earlier terminated as provided herein. The County has the option of renewing this Agreement for one (1) additional two (2) year periods at the same terms and conditions outlined herein.

B. Effective Date. This Amendment shall be effective upon execution by the Parties.

C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
