Description:

Purchase Order BCI Integrated Solutions, in the amount of \$52,491.06 for Bid 25-71-MB Annual On-Demand Repairs, Maintenance, Upgrades, Installation and Emergency Services for the LenelS2 OnGuard Access Control System, for Facilities Management.

Approve the issuance of a Purchase Order to BCI Integrated Solutions, in the amount of \$52,491.06.

Prior Board Motions:

April 8, 2025, the Board approved the Award of Bid 25-71-MB Annual On-Demand Repairs, Maintenance, Upgrades, Installation and Emergency Services for the LenelS2 OnGuard Access Control System for Facilities Management to BCI Integrated Solutions as the primary and Security 101 Holdings, LLC, as the secondary, lowest, most responsive, and responsible vendors. Background:

The County utilizes the LenelS2 OnGuard system as its primary access control platform across multiple facilities. This system is a critical component of the County's physical security infrastructure, managing electronic access to secure areas through badge readers, door controllers, and centralized monitoring.

Due to the proprietary nature of the LenelS2 OnGuard platform, only companies that are authorized and certified by the manufacturer are permitted to perform installation, maintenance, or service on these systems. Working with unauthorized vendors could compromise the integrity of the system and void product warranties or software licensing agreements.

Therefore, to ensure compliance with manufacturer requirements and maintain the operational integrity and security of our facilities, the County specifically sought responses from vendors that are certified by LenelS2 to support the OnGuard platform.

At the time the County acquired the former Burkhardt Warehouse property, the only existing security measures were perimeter fencing and a basic security camera system. To ensure the safety of County staff and protect County assets, a card access system should be installed and integrated with the County's existing LenelS2 OnGuard access control platform.

BCI, the selected vendor through a competitive bid process, has provided Quote No. 05072025MK02 for installing access control at the Facilities Warehouse.

Bid 25-71-MB Annual On-Demand Repairs, Maintenance, Upgrades, Installation and Emergency Services for the LenelS2 OnGuard Access Control System was released on January 22, 2025. The deadline for receipt of Bid 25-71-MB Annual On-Demand Repairs, Maintenance, Upgrades, Installation and Emergency Services for the LenelS2 OnGuard Access Control System was February 26, 2025; four (4) vendors responded.
