## ALACHUA COUNTY 1 **BOARD OF COUNTY COMMISSIONERS** 2 3 5 6 7 RESOLUTION NO. 2025-030 8 9 10 A RESOLUTION OF THE BOARD OF COUNTY COMMISIONERS OF 11 ALACHUA COUNTY, FLORIDA, RELATING TO THE DELIVERY 12 **FUNDING FIRE PROTECTION** OF **SERVICES** 13 FACILITIES WITHIN THE ALACHUA COUNTY MUNICIPAL 14 SERVICE BENEFIT UNIT FOR FIRE PROTECTION SERVICES 15 **RESTATING AND RENEWING RESOLUTION 2017-70 REGARDING** 16 THE FIRE PROTECTION ASSESSMENT DIRECTING THE COUNTY 17 MANAGER OR HIS DESIGNEE AS ASSESSMENT COORDINATOR 18 TO **PREPARE** A **PRELIMINARY** ASSESSMENT 19 ESTABLISHING A PUBLIC HEARING TO CONSIDER IMPOSITION 20 OF THE PROPOSED SPECIAL ASSESSMENTS: DIRECTING THE 21 PROVISION OF NOTICE IN CONNECTION THEREWITH; AND 22 PROVIDING AN EFFECTIVE DATE. 23 24 25 26 WHEREAS, the BOARD OF COUNTY COMMISSIONERS has established a fire 27 protection MSBU and established a method of fairly apportioning the cost of fire protection 28 services through a non-ad valorem assessment by way of the adoption of Resolution 2017-70; and 29 30 WHEREAS, the BOARD OF COUNTY COMMISSIONERS used the same methodology of assessment for tax year 2018-19, 2019-20, 2020-21, 2021-22, 2022-23, 2023-24,2024-25, 2025-31 26; and 32 WHEREAS, the BOARD OF COUNTY COMMISSIONERS have determined to use the 33 same methodology of assessment for tax year 2025-26 and fiscal year 2025-2026; and 34 WHEREAS, the BOARD OF COUNTY COMMISSIONERS has arranged with the Tax 35 Collector and Property Appraiser for the notification regarding the assessments and the collection 36 37 of the assessments through the established TRIM process.

1 2	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
3	COMMISIONERS OF ALACHUA COUNTY, FLORIDA:
4 5	<b>Section 1.</b> The provisions of Resolution 2017-70 shall be applied for the 2025-26 tax year
6	and fiscal year 2025-2026 with the modifications set forth herein.
7	Section 2. The Board imposes a non-ad valorem assessment for fire protection against real
8	property located in the Alachua County Municipal Service Benefit Unit for Fire Protection
9	Services which includes the unincorporated area of the County and the Cities of Alachua,
10	Archer, Hawthorne, Micanopy, and Waldo ("MSBU").
11	<b>Section 3.</b> The methodology for the assessment shall be set forth in Resolution 2017-70. The
12	County Manager is directed to update the assessment roll.
13	Section 4. The amount of the annual fire protection assessment revenue that will be collected
14	by the MSBU for FY2025-2026 is estimated to be \$23,505,318.00
15	<b>Section 4.</b> The maximum rates for Tier 1 and Tier 2 to be assessed for FY 2025-26 shall be
16	based upon a Tier 1 Maximum Assessment Rate of \$132.47 per Tax Parcel and Tier 2 shall be
17	based upon a Maximum of \$7.28 per EBU.
18	Section 5. A public hearing to establish the final assessment shall be held on September 11 <sup>th</sup> ,
19	2025, at 5:01 p.m.
20	Section 6. The form of the mailed notice shall be that which is attached hereto as Attachment
21	A. Such notice contains the appeal rights of the property owners, method of assessment and the
22	notice of the final hearing which shall be mailed with the TRIM notices by First Class Mail.
23	Section 7. The County Manager shall publish a notice of the public hearing authorized by

Section 6 above in the manner and at the time provided in Section 197.3632, Florida Statutes in

1	substantially the form attached hereto as Attachment B and shall be published no later than August
2	21, 2025.
3	Section 8. This Resolution shall become effective immediately upon adoption.
