Alachua County has a population of over 250,000 and a regional airport. The County itself consists of a total area of 969 square miles.

In addition to the five County Commissioners, there are five elected Constitutional Officers: Supervisor of Elections, Sheriff, Clerk of the Court, Tax Collector, and the Property Appraiser. The Alachua County Attorney also reports to the Board.
