

**SECOND AMENDMENT TO CONTINUING SERVICES AGREEMENT BETWEEN ALACHUA COUNTY AND TWO-FOLD WATER ENGINEERING INC., NO. 13716**

THIS SECOND AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and TWO-FOLD WATER ENGINEERING INC., a Florida for profit corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Continuing Services Agreement dated February 24, 2023 for Annual Water Systems Monitoring and Inspection, identified by No. 13716 (the “Agreement”); and

**WHEREAS**, the Parties previously entered into the First Amendment to the Agreement dated September, 2023 (the “First Amendment”); and

**WHEREAS**, the County has determined there is a need to add the certain Services at the Alachua County Agriculture & Equestrian Center; and

**WHEREAS**, the Parties desires to amend the Agreement to add the location as provided herein.

**NOW, THEREFORE**, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Exhibit #1, of the Agreement titled “Scope of Services”, Paragraph 2, titled Locations is amended to add Sub-Paragraph 2.1.11 to read as follows:

W Newberry Rd, Newberry, FL 32669**

Number of wells: 1

Number of Chlorine Pumps: 1

Number of Annual Nitrate/Nitrite Tests: 1

Number of Quarterly Bacteriological Tests: 2

B. Amendment. Exhibit #2, of the Agreement titled “Rate Schedule”, specifically the table for Regular Services, is amended to add the following. All other portions of the Rate Schedule remain unchanged by this Amendment.

Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
