# Description:

Second Amendment to the Agreements with T&K Enterprises of Volusia County, Inc. (14019), Clear Zone Maintenance, Inc. (14020), and GRSC, Inc. (14021), for BID 24-54-MB Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal, not to exceed (NTE) \$500,000.00 annually, for Public Works. This amendment extends the term through September 30, 2026.

May 28, 2024, the Board approved the First Amendments for BID 24-54-MB Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal to T&K Enterprises of Volusia County, Clear Zone Maintenance, Inc. and GRSC, Inc., NTE \$500,000.00 annually for Public Works. Item 24-00470.

January 9, 2024, the Board approved the Agreements for BID 24-54 Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal to T&K Enterprises of Volusia County, Clear Zone Maintenance, Inc. and GRSC, Inc., NTE \$500,000.00 annually for Public Works. Item 24-00017.

November 14, 2023, the Board approved the Award of BID 24-54 Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal to T&K Enterprises of Volusia County, Clear Zone Maintenance, Inc. and GRSC, Inc., NTE \$500,000.00 annually for Public Works. Item 23-00735.

# **Background:**

These Second Amendments are for the purpose of renewing/extending the term of each agreement for an additional one-year period and to add required statutory provisions that were recently mandated by state law. This solicitation was awarded to three vendors based on availability, unit costs, and nature of work.

BID 24-54-MB Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal was released July 19, 2023. The deadline for receipt BID 24-54-MB Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal was August 16, 2023; six (6) vendors responded.
