

**AMENDMENT TO AGREEMENT WITH T&K ENTERPRISES OF VOLUSIA COUNTY INC.
FOR ANNUAL TREE TRIMMING, TREE REMOVAL, TREE DEBRIS HAULING AND
DISPOSAL NO. 14019**

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and T&K ENTERPRISES OF VOLUSIA COUNTY, INC., a Florida for profit corporation, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement dated January 11, 2024 for Annual Tree Trimming, Tree Removal, Tree Debris Hauling and Disposal, identified by No. 14019 (the "Agreement"); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County and to add service locations; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. **Amendment.** Section #3, of the Agreement titled "Term" is amended to read as follows:

3. **Term.** This Agreement is effective upon execution by both Parties and continues until September 30, 2025, unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for two additional one-year term(s) at the same terms and conditions outlined herein. The Contractor may choose not to renew this Agreement provided the Contractor sends the County written notice ninety (90) days prior to October 1st for each term renewal.

B. **Amendment.** Section #2, titled "List of roadway segments for ROW trimming", of the Exhibit 1 of the Agreement titled "Scope of Work", is amended to add the following areas of service:

- C. **Amendment.** Exhibit #2, titled "Rate Schedule", is amended to add the following costs for additional areas of service:

Row Trimming	SW 122 nd St from Newberry Rd (SR26 to South of SW 2 nd Pl)	1	Miles	\$3,985.00	\$3,985.00
Row Trimming	SW 8 th Ave from SW 75 th St (Tower Road to SW 91 st St)	0.9	Miles	\$5,494.44	\$4,945.00


- D. **Effective Date.** This Amendment shall be effective upon execution by both Parties.

- E. **Original Agreement.** Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
